## **Purpose**

This report is prepared by the Federation for the Humanities and Social Sciences (Federation) and provides information about the Awards to Scholarly Publications Program (ASPP) for the program year April 2020 to March 2021. It provides details on two distinct areas of the program: works funded and operational activities.

#### **About the ASPP**

The Awards to Scholarly Publications Program is a key activity of the Federation for the Humanities and Social Sciences. Formerly known as the Aid to Scholarly Publications Program, the ASPP is a competitive funding program with a mandate to support books of advanced scholarship in the humanities and social sciences that make an important contribution to knowledge. Since 1941, the ASPP has supported the publication of over 7,500 books that have helped to enrich the social, cultural and intellectual life of Canada and the world.

Each year, the ASPP offers approximately 180 publication grants of \$8,000 and five translation grants of \$12,000, contributing about \$1.5 million to the dissemination of Canadian research.

The ASPP is funded by the Social Sciences and Humanities Research Council of Canada and administrated by the Federation.

## Report on works funded

All ASPP grants are approved in principle prior to publication, and are paid out following publication, directly to the publisher.

#### Summary

The ASPP paid out 176 publication grants and 7 translation grants from April 1, 2020 to March 31, 2021. See Appendix A for a complete list of works that were supported by the ASPP in the 2020-21 year.

## **Report on operational activities**

## **Review of the Canada Prizes**

The Canada Prizes – Prix du Canada are awarded annually to books in the humanities and social sciences that have received funding from the ASPP. Finalists and winners are chosen by an independent jury of scholars. The winning books make an exceptional contribution to scholarship, are engagingly written, and enrich the social, cultural and intellectual life of Canada.

In June 2020, the jury awarded the 2020 Prix du Canada to the authors of *Les Bois-Brûlés de l'Outaouais*. *Une étude ethnoculturelle des Métis de la Gatineau*. This generated widespread controversy both about



the book's authors and the book's subject of Métis identity. Following the jury's decision, the Federation spoke with scholars, including Métis scholars, who have deep concerns and criticisms with about this book.

The Federation has paused the Canada Prize award for 2021, and has committed to fully reviewing the program with the aim of making all necessary changes to support reconciliation, better address anti-Black racism, and more fully imbed the principles of equity, diversity, and inclusion in the Canada Prize – Prix du Canada.

The Federation will be working with a consultant over the summer of 2021 in order to review the prizes with the following goals: to preserve and enhance the core prize format; address inequities in all aspects of the program; lower barriers to participation among members of underrepresented groups; and improve governance and administration. The goal is to re-launch the prize program for the 2022 calendar year.

## **Program Evaluation**

During the 2020-21 program year, the Federation continued its participation in the SSHRC Evaluation Advisory Committee's work to examine the Award to Scholarly Journals and the Award to Scholarly Publishing Programs. The report was finalized in the summer of 2020 and SSHRC completed its Management Response and Action Plan in early 2021. The evaluation and its conclusions informed the proposal that the Federation submitted to SSHRC in January 2021.

## **Proposal to SSHRC**

In January 2021, the Federation presented to SSHRC a proposal to update the Awards to Scholarly Publications Program. The Federation began working on a proposal for the future of the ASPP in March 2018. We initiated this project when SSHRC, the ASPP's chief funder, asked us for a plan to integrate new Open Access (OA) requirements into the program. The project's scope grew in the interim, and, as a result, the proposal now speaks not only to OA but to a broad group of other issues as well.

The proposal was shaped by extensive research and consultations. It reflects the preliminary findings of SSHRC's most recent ASPP evaluation, and a pair of research reports commissioned by the Federation in 2018, including an in-depth analysis by Delphine Lobet and Vincent Larivière of the Université de Montréal.

The proposal includes recommendations regarding changes and improvements to the ASPP funding mechanism, Open Access, data collection, diversity, equity, inclusion, Indigenous research, communication and marketing.

In the proposal, we recommend a two-phase approach to implementation, with much of the first phase (Jan-Dec 2021) dedicated to refining key elements of the proposal and developing a more detailed, multi-year implementation plan. Critically, this will need to include further consultations with key stakeholders. Phase 1 includes revising program objectives and developing action plans for EDI, Indigenous research, financial reporting, and dissemination, for implementation beginning in 2022. The

second phase (Jan-Dec 2022) includes developing a detailed proposal and transition plan for a new funding distribution system, and developing a strategy to ensure researchers include book publication funding in research grant applications

## New grants management software

In 2018, the Federation approved a project to implement a grants management software to streamline the application process, simplify the assessment of grant applications, and serve as a searchable database of funded works. A software was selected at the beginning of 2019 and we have focused on building the framework and setting up the workflow. The launch of the software is now expected to happen in the third quarter of 2021 and once in use, it will allow the program to operate more efficiently for all parties, including staff, publishers, and reviewers.

## **Application assessment and approval level**

The ASPP uses the following numerical assessment system for publication grant applications:

Score	Descriptor
5.0-6.0	Excellent. Strongly recommended for funding. The work is at the forefront of its field, and it will have significant impact within its discipline. The work's methodological/theoretical framework is strong. The manuscript is well structured and well written. The work's contribution to knowledge is important.
4.0-4.9	Very good. Recommended for funding. The work meets all the standards for high quality within its field and makes a major contribution within its discipline. The work's methodological/theoretical framework is sound, though some parts of it might have been strengthened. The manuscript has structural integrity, and is generally well written. The work's contribution to knowledge is of some importance.
3.0-3.9	Good. Recommended for funding if funds are available. The work meets most of the standards for high quality within its field, and makes a modest though interesting contribution within its discipline, but lacks distinction in at least one of the following areas: methodological/theoretical framework, structure, writing style, and/or importance.
2.9 or less	Not recommended for funding. The work meets some of the standards for achievement within its field, but makes only a limited contribution within its discipline, and is flawed in at least one of the following areas: methodological/theoretical framework, structure, writing style, and/or importance.

The ASPP's Publications Committee, which assesses applications for the awarding of publication grants, scores each application according to this scale. Each application is then ranked along with all other applications scored in that month and the top ranking applications are approved.

The **monthly cut-off point** for this program year was approximately **4.3**, and no application scoring 4.7 or above was declined for funding. This cut-off point is not fixed and may change in subsequent years.

Of the 98 applications still in process at the conclusion of the 2020-2021 year, **84** were for works in **English** and **14** were for works in **French**.

## **Approval rate**

Between April 1, 2020 and March 31, 2021, there were 237 publication grant applications that were processed and brought to resolution. Of these, 180 were approved, for an **overall approval rate** of **76%**.

## **Translation grants**

Each year, the ASPP awards up to five translation grants to support translations of scholarly books. The ASPP's Academic Council meets twice a year to make decisions on the awarding of translation grants. The ASPP received five translation grant applications in 2020-2021 and **awarded four grants**.
